The ordinance creates a process through which the Building Official is able to address structures which become unfit or unsafe for habitation, or which create a danger to public safety or health, to include requiring the structure be secured or demolished. The ordinance sets forth a due process standard to ensure an owner receives ample process to contest any securing or demolition order.
