**PRESENTATION:** Kevin Ruane, Mayor, City of Sanibel

New criteria established by the South Florida Water Management

District

Mayor Ruane addressed the recent water quality conditions and the overwhelming impacts to quality of life, the local economy, tourism, and the real estate market. He requested that the Village support the effort by local communities to challenge new criteria established by the South Florida Water Management District (SFWMD) related to minimum flows and levels affecting the Caloosahatchee River, as well as supporting a joint petition, as an intervenor, to challenge proposed rules being established by the SFWMD in a legal action in support of more rigorous rules that may lessen the impacts of poor water quality.

Discussion included applications accepted prior to a disaster; consumer protections; best practices; some cities have come up with additional required guidelines; fees; inquiry regarding five Florida municipalities that participate; length of time they have been in Florida; whether they give references; whether there was sentiment on the Council to move forward; whether this could be put in place for commercial property only; approximately 70% of Florida cities have the program; limited Village staff time. Consensus was not to move forward at this time.

## (c) Retail Gas Pump Security Measures Ordinance

Village Attorney Saunders introduced the ordinance and stated that it would provide consumers with a little more assurance; State law was ineffective; and state agency representatives testified in favor of such an ordinance when the City of Cape Coral adopted their ordinance.

**Questions or Comments:** Councilmembers Levitan, McLain, Errington and Vice Mayor Ribble. Discussion included adding language regarding updating the locks when technology changed. Village Attorney Saunders noted that it would be difficult to add language regarding that in the ordinance; however, if technology changed, the ordinance could be amended.
