REQUEST AND STAFF RECOMMENDATION

This is a request for "Consumption on Premises" (2COP-beer and wine) for the proposed Burgerim restaurant with outdoor seating in Coconut Point next to the movie theater. Staff recommends approval with conditions.

PROJECT HISTORY

The property is located within the Coconut Point Development of Regional Impact (DRI). It was rezoned from Agricultural (AG-2) to Mixed Planned Development (MPD) on October 21, 2002.

The specific site (tenant space) is approximately 2,183 square feet and was previously occupied by Johnny Rockets Restaurant.

PROJECT DESCRIPTION

The proposed restaurant will be located in the central section of Coconut Point fronting Cinema Way. There are several retail/commercial establishments located in the vicinity of the proposed Burgerim restaurant. Other restaurants with Consumption on Premises located in the vicinity of the proposed Burgerim restaurant include Brass Tap and Amore Brick Oven Pizza. Both of these restaurants are located approximately 50 feet to the southwest of the proposed tenant space.

Johnny Rockets previously operated from the 2,183 square foot tenant space. The new tenant (Burgerim) is a fast casual restaurant serving hamburgers, salads, sandwiches and proposes to serve beer and wine. A food menu is provided (See attachment). The outdoor area is approximately 505 square feet and will be partitioned with landscape planter and 24 seats. The hours of operation are Monday through Sunday from 10:00 am to midnight.

The Burgerim restaurant includes an inside dining area (56 seats) and an outdoor seating capacity of 24 seats. A total maximum capacity of 88 persons including staff are expected at peak hours of operation.

STAFF ANALYSIS

The applicant is requesting a "Consumption on Premises" (2COP) approval with outdoor seating. A 2COP license for beer and wine in conjunction with a standard restaurant is currently listed as a permitted use for Tract 2A in previously approved Resolution Z-02-009.

Consumption on Premises with outdoor seating in conjunction with a Group II, III or IV restaurant is permitted if the outdoor seating area is not within 500 feet of a religious facility, school (non-commercial), day care center (child), park or dwelling unit under separate ownership. The Applicant complies with the distance requirements for outdoor seating.

The applicant has indicated if zoning approval is granted for the 2COP, an application will then be submitted to the State of Florida "Division of Alcoholic Beverages and Tobacco for a 2COP license.

A letter of approval from the Simon Property Group was obtained by the Applicant for the proposed Burgerim Restaurant. The proposed Burgerim Restaurant will not have any apparent impact upon surrounding properties. The subject space is suitable in regard to location, site characteristics and intended purpose. There are two nearby establishments which sell alcoholic beverages for consumption in the vicinity of the proposed Burgerim Restaurant. No outdoor entertainment has been requested. The Applicant meets the intent of Section 34-1264 of the Land Development Code and the administrative requirements for an administrative approval.

RECOMMENDATION

If the Planning and Zoning Board wishes to approve the Consumption On Premises, the following conditions have been incorporated in the Planning and Zoning Board resolution:

- 2COP to be in conjunction with the restaurant operation;
- Approval is limited to the sale and service of alcoholic beverages between the hours of 10:00am to midnight, Monday through Sunday for both indoor and outdoor seating;
- No outdoor entertainment on premises.




