Agenda Item:

Traffic Signal, Street Light and Traffic Sign Standards

Description:

The Village of Estero does not currently have uniform standards for traffic signals, street lights or traffic signs. Traffic signals vary from intersection to intersection, street light vary from road to road and generally traffic signs are FDOT standard signs with the exception of a few areas within or adjacent to master planned communities.

Some communities have established uniform standards to improve aesthetics and differentiate their community from others.

The presentation provides examples from other communities and summarize potential costs that could be incurred if standards are implemented.

Financial Impacts:

No financial impacts at this time.

If standards are implemented in the future, both capital and operation/maintenance funds will be required.



Does Estero want a Standard?

- Provides/expands on Village identity
- Expand/build on standards established within gated communities
- Differentiate Estero from surrounding communities
- Additional cost







- 21 Signals within Estero
 - Most are galvanized mast arms (9) or cable and span wire (5)
 - Painted signals (7) are maintained by adjacent communities
 - Except, US-41 & Coconut











Cost Considerations-Traffic Signal

• Traffic Signals

- Strip existing pole & repaint \$20,000 \$30,000 ea.
- Paint galvanized poles \$10,000 \$15,000 ea.
- Maintenance Inspect annually, repair as needed
- Maintenance Repaint every 5-7 years (\$20,000 \$30,000 ea.)
- New Traffic Signals \$500,000 \$600,000
- Replacement Costs
 - Replace cable and span wire: 5 x \$600,000 = \$3,000,000
 - Paint Galvanized: 9 x \$15,000 = \$135,000
 - Repaint: 7 x \$30,000 = \$210,000
 - Total = \$3,345,000

Cost Considerations-Street Lights

- Light Poles
 - Replacing \$3,000 per pole
 - Painting \$1,000 per pole
- Maintenance Repaint every 5 10 years (\$500 per pole)
- Replacement Costs
 - Three Oaks Parkway: 50 x \$3,000 = \$150,000
 - Ben Hill Griffin Parkway: 26 x \$3,000 = \$78,000
 - Corkscrew Road: 43 x \$3,000 = \$129,000
 - Via Coconut Point: 8 x \$3,000 = \$24,000
 - Total = \$381,000

Cost Considerations-Traffic Signs

• Options

- Decorative \$1000 per sign
- Standard \$325 per sign
- Decorative Sign Maintenance Repaint every 7-10 yrs. (\$150 per sign)
- Replacement Costs
 - Corkscrew Road: Est. 210 signs x \$1000 = \$210,000
 - \$210,000/5.3 miles = \$40,000/mi.
 - 26.2 miles of roadway = \$1,050,000 est.

Signal Options

1. As is

- New signals likely galvanized
- Replacements galvanized
- 2. Standard for New/Replacement Signals
 - Establish standard but only apply to new or replacement signals
- 3. Standard for Signals
 - Establish standard and actively replace existing signals to meet standard

Note: Village only owns one traffic signal. All others owned by LDOT of FDOT

Street Light Options

1. As is

- Maintain existing lights
- New lights selected on case by case basis
- 2. Standard for New/Replacement Street Lights
 - Establish standard but only apply to new street lights
 - Would effectively never expand to Village wide standard
- 3. Standard for Street Lights
 - Establish standard and actively replace existing lights to meet standard

Note: Village only owns street lights on US-41 and other Village maintained roads. To fully implement any standard Village would need to replace Lee County lights on Three Oaks Pkwy, Corkscrew Road and Ben Hill Griffin Pkwy.

Traffic Sign Options

1. As is

- Maintain existing signs
- All new sign meet FDOT standard
- 2. Standard for New/Replacement Signs
 - Establish standard but only apply to new or replacement signs
- 3. Standard for Signals
 - Establish standard and actively replace existing sign to meet standard

Note: Village only owns signs on Village maintained roadways. To get the standard implemented along all roadways the Village would need to install/maintain signs on County and/or FDOT roadways.
