9 10	WHEREAS, Resolution No. 2018-15, adopted the 2018-2019 fiscal year budget; and
11	WHEREAS, Resolution No. 2010-15, adopted the 2010-2017 fiscal year budget, and
12	WHEREAS, the Village has approved a capital improvement project to enhance
13	landscaping on US 41.
14	The estimated costs are \$1,265,590 with an additional \$95,000 requested for a
15	construction contingency. Total project costs of \$1,360,590 include two years of landscape
16	maintenance which were not contained in the original project budget.
17	The project will receive \$766,000 in funds from the Florida Department of
18	Transportation (FDOT).
19	The budget includes \$1,175,990 for this project; therefore, \$184,600 of additional funds
20	will be required. The additional funds are available in general fund unencumbered prior year
21	surplus; and
22	
23	WHEREAS, as provided in the Village Charter Section 8(6)(d), the following transfer
24	of unencumbered appropriations will be added to the 2018-2019 Budget.
25	NOW THEREFORE has it reached by the Village Coursel of the Village of Estern
26 27	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero, Florida:

29	Section 1. Transferring additional funding of \$184,600 to US 41 Landscaping
30	Enhancement contained in Capital Projects budget line item (300-000-511-6300) from general
31	fund unencumbered prior year surplus.
