FDOT Beautification Grant Application

Resolution No. 2019-19 A resolution of The Village Council of The Village of Estero, Florida, authorizing the Village Manager or his designee to apply for and accept a beautification grant from the Florida Department of Transportation; and further authorize the Village Manager to enter into a beautification grant, landscape construction, and maintenance memorandum of agreement with the Department of Transportation

Description:

The Village of Estero is proposing to submit two grant applications to the Florida Department of Transportation to pay for the installation of landscaping along US-41.

The State of Florida, Department of Transportation (FDOT) beautification grant, if approved, could provide funding for up to two separate landscaping projects along US-41. The project would include installation of landscaping along roadway shoulders and installation of trees along the shoulders and median islands. Funding could be approximately \$100,000 per project.

These projects would compliment the ongoing US-41 median landscaping project and potentially provide a framework to provide additional landscaping including trees within the roadway medians and shoulders.

Action Requested:

Adopt Resolution No. 2019-19 and authorize the Village Manager to submit the grant application and execute an agreement on behalf of the Village of Estero Council.

Financial Impact:

There is no direct financial impact associated with this resolution.

However, preparing the two grant applications and associated landscape construction plans is expected to cost \$27,500.

The Village would also be required to pay for any construction costs in excess of the grant funding and maintain all landscape improvements after construction.
