## Agenda Item:

Right of Way Review Services RFQ 2019-02

### **Description**:

A Request for Qualifications was proffered by the Village for the engagement of a firm(s) to provide professional services to assist the Village in reviewing right of way permit applications. This process included the solicitation of Letters of Interest from firms, the short listing of firms by an evaluation committee, and the determination of a final pool of vendors following a second contact with the short listed firms.

The action requested approves the recommended pool of vendors, authorizes the negotiation of contracts with execution by the Village Manager, and compensation on an as-needed basis up to an annual not-to-exceed amount of \$50,000 per firm (total \$100,000).

Staff has attached firm ownership disclosure of greater than 5% as recommended by the Village Attorney.

### Action Requested:

Concur with the recommendation of the evaluation committee to select the two (2) firms that submitted Letters of Interest, authorize the negotiation of contracts for a period of one (1) year with the option to renew for three (3) additional one (1) year periods with an annual not-to-exceed expenditure amount of \$100,000. The firms are: Kimley-Horn and Associates, Inc. and Q. Grady Minor & Associates, P.A.

Authorize the Village Manager to execute agreements on behalf of the Village of Estero Council.

### Financial Impact:

To be determined on a per project basis; but not-to-exceed \$100,000 on an annual basis.

Grady Minor & Associates, P.A.
