#### **Commercial Structure Paint Permit**

All exterior painting of any commercial structure must meet Section 33-334 of the Land Development Code as follows:

Design Standards: Sec. 33-334. Building Color

- (a) The colors for commercial structures must be neutral, warm earth tones or subdued pastels. Where applicable, commercial buildings may use brightly colored trims, cornices, or columns that may be reinforced to create a special effect or setting. However, these contrasts must create harmonious impact, complementing the principal structure as well as existing surrounding building structures.
- (b) Brighter colors can be utilized to create focal points of interest in locations including on doors, windows and architectural detail in composite. Contrasting accent colors of any wall, awning or other feature must be limited to no more than ten percent of the total area for any single facade.

- -Arches around windows shall be painted SW 2819 Downing Slate
- -Existing faux window shall be painted SW7691 Biltmore Buff
- -All areas currently green shall be painted SW2819 Downing Slate U.N.O.
- -Existing stone base shall be painted SW7691 Biltmore Buff

## **Option Two:**

- Existing trim to remain white
- -All areas currently rust and yellow shall be painted SW7691 Biltmore Buff, this shall include any reaming ornamentation
- -Existing faux window shall be painted SW7691 Biltmore Buff
- -Existing stone base and metal man doors shall be painted SW7691 Biltmore Buff
- -Arches around windows shall be painted SW2833 Roycroft Vellum
- -Existing faux window shall be painted SW7691 Biltmore Buff
- -All areas currently green shall be painted SW2833 Roycroft Vellum U.N.O.

- Existing trim to remain white
- -All areas currently rust and yellow shall be painted SW2833 Roycroft Vellum, this shall include any remaining ornamentation
- -Existing faux window shall be painted SW2833 Roycroft Vellum
- -Existing stone base and metal man doors shall be painted SW2833 Roycroft Vellum
- -Arches around windows shall be painted SW2834 Birdseye Maple
- -All areas currently green shall be painted SW2834 Birdseye Maple U.N.O.
- -Existing stone base shall be painted SW2833 Roycroft Vellum
