14	WHEREAS, Resolution No. 2019-24, approve the first budget amendment		
15	transferring additional funding of \$428,240 to Estero Parkway Improvements from general		
16	fund unencumbered prior year surplus; and		
17			
18	WHEREAS, the second budget amendment was completed by the Village Manager to		
19	remove one staff person (full time equivalent) from personal service and transfer budgeted		
20	funds into professional services in the Public Works function. This budget amendment had no		
21	net effect on the 2019-2020 budgeted expenditures; and

23	WHEREAS, the Village would like to award RFB 2020-08 Trailside Drive and		
24	Poinciana Avenue Resurfacing/Rebuild with estimated project costs of \$415,447 including a		
25

27	Resurfacing/Rebuild project; \$148,000 in Major Road Maintenance Reserve; and the		
28	remainder of \$115,447 from general fund operating contingency; and

30	WHEREAS, as provided in the Village Charter Section 8(6)(d), the following transfer		
31	of unencumbered appropriations will be added to the 2019-2020 Budget.

33	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,

36	Section 1. Transferring funding of \$148,000 from the Major Road Maintenance		
37	Reserve and \$115,447 from the general fund operating contingency into the Trailside Drive
