Contractor Registration Form

The Village of Estero Building and Permitting Services requires registration of all contractors applying for building permits in the Village of Estero.

The documents necessary for registration include:

- Completed Contractor Registration Form
- Authorized Agent Affidavit (if applicable)
- Copy of an active State License or Lee County Competency Card
- Proof of Liability Insurance
- Proof of Worker's Compensation Insurance or Workers Compensation Exemption Certificate
- There is NO charge for registration

Note: Village of Estero shall be listed as a Certificate Holder (for notification purposes only).

The Contractor or Authorized Agent may deliver the documents to the Village of Estero Building and Permitting Services Department when applying for the first building permit. Registration will be completed over the counter. Alternatively, this application and all required documents may be emailed or faxed to the Village of Estero at the contact numbers above.
