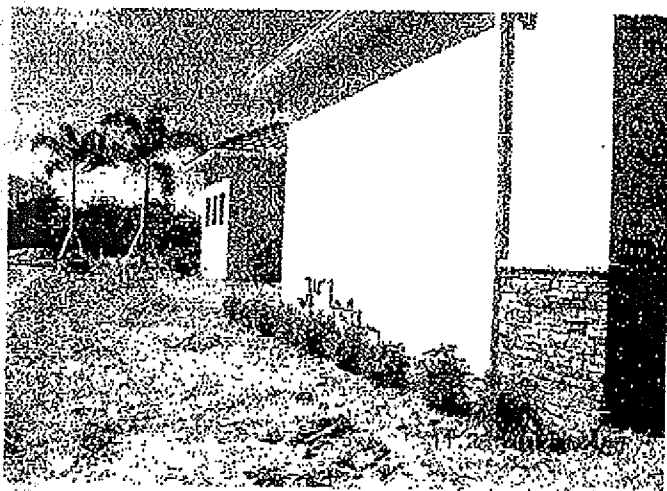

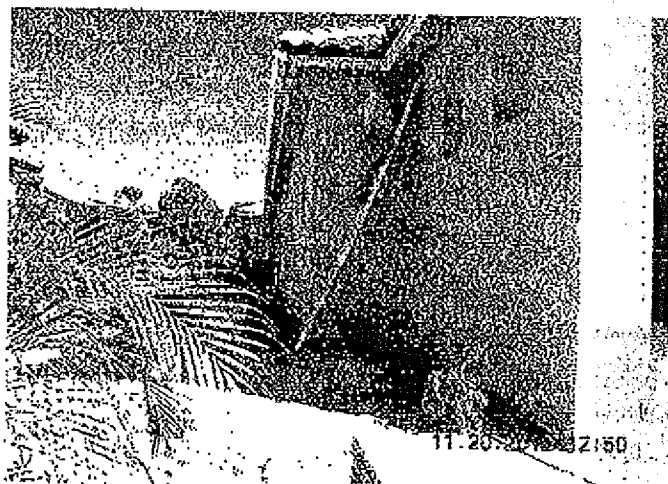
FRONT VIEW
