45 **WHEREAS**, the County and Village desire to accomplish the continued assessment
46 through September 30, 2018, for the installation and maintenance of landscaping and
47 vegetation over and above the County's "core level" on those portions of Corkscrew Road,
48 Ben Hill Griffin Parkway and Estero Parkway as may now be located within the incorporated
49 boundary of the Village.

50
51 **WHEREAS**, the Village approved Village of Estero, Florida, Ordinance No. 2016-
52 11, to consent to initial continued participation in the University Landscaping MSBU through
53 December 31, 2017, the terms and conditions of which are incorporated herein by reference;
54 and

56 **WHEREAS**, on August 31, 2016, the County and the Village approved a companion
57 Interlocal Agreement accepting administration of the University Landscaping MSBU by the
58 County on behalf of the Village through December 31, 2017, including any extensions, the
59 terms and conditions of which are incorporated herein by reference.

61 **NOW THEREFORE**, be it ordained by the Village Council of the Village of Estero,
62 Florida:

64 **Section 1.** **Recitals.**

66 The foregoing recitals are true and correct and incorporated herein by this reference.

68 **Section 2.** **Authority.**

70 1. As a result of the adoption of this Ordinance the Mayor of the Village of Estero is
71 hereby authorized to execute any necessary extension of the August 31, 2016
72 Interlocal Agreement between the Village and the County to facilitate the
73 County's continuation in assessing the non-ad valorem assessment, collecting the
74 same and administering the University Landscaping MSBU.
75
76 2. The intended result of this Ordinance is the continued operation of the University
77 Landscaping MSBU for those benefitted properties now located within the
78 municipal boundary of the Village through September 30, 2018.
79
80 3. This Ordinance is adopted pursuant to the requirements of Florida Statutes
81 §125.01(q), to consent to the continuation of the University Landscaping MSBU
82 to the extent benefitted properties and certain roadways are located within the
83 Village;

85 **Section 3.** **Term.**

86
87 This Ordinance is adopted to extend the term of the August 31, 2016 Interlocal
88 Agreement between the Village and the County through September 30, 2018. Further, this

Ordinance may be extended by a subsequent amendment and affirmative vote of the Village Council.

Section 4. Effective Date.

This Ordinance shall become immediately effective upon its adoption by the Village Council.
