22	welfare of the Village and its residents to rescind certain provisions of the Lee County Code			
23	that fall into one of the following categories: non-ordinance provisions, provisions pre-empted			
24	to counties, provisions specifically related to county departments, officers, agencies or areas			
25	outside of Estero, provisions that would apply within Estero without the Village's adoption of			
26	same.
