## 1 VILLAGE OF ESTERO, FLORIDA 2 3 **ORDINANCE NO. 2020 - 05** 4 5 AN ORDINANCE OF THE VILLAGE COUNCIL OF 6 VILLAGE **OF** ESTERO, FLORIDA, 7 ADOPTING AN OFFICIAL VILLAGE SEAL; 8 PROVIDING FOR CONFLICT; PROVIDING FOR 9 SEVERABILITY; **PROVIDING FOR** 10 CODIFICATION; PROVIDING AN EFFECTIVE 11 DATE. 12 13 WHEREAS, Section 165.043, Florida Statutes, authorizes the governing body of a municipality, by ordinance, to designate an official municipal seal to be affixed on all official 14 15 actions or documents of the City and to identify and authenticate documents; and 16 17 WHEREAS, Section 165.043, Florida Statutes, provides that it is a second-degree misdemeanor to manufacture, display, or otherwise use the municipal seal, except with the 18 19 express consent of the municipal governing body; and 20 21 WHEREAS, the Village Council of the Village of Estero finds that it is in the best interest of the Village to adopt a seal as the Official Seal of the Village, and finds that it is in 22 23 the Village's best interest to ensure that its Official Seal has the legal protections afforded to 24 seals by formal ordinance. 25 26 NOW, THEREFORE, BE IT ORDAINED by the Village Council of the Village of 27 Estero, Florida, as follows: 28 29 Recitals. Each and all of the foregoing recitals are hereby incorporated Section 1. 30 into this Ordinance as if specifically set forth herein and adopted as findings of fact. 31 32 **Section 2.** The Village of Estero hereby adopts as its official seal: 33
