The following language is stricken from the Proposal Quote Form (page 10):

IN THE EVENT THAT PERMITS ARE DELAYED OR THE VILLAGE'S CONTRACTOR IS NOT READY TO TAKE DELIVERY OF THE BRIDGE STRUCTURE IT MAY BE NECESSARY FOR THE BIDDER TO STORE THE BRIDGE UNTIL THE VILLAGE'S CONTRACTOR IS READY FOR DELIVERY. PLEASE PROVIDE A MONTHLY RATE TO STORE THE BRIDGE STRUCTURE.

Responses/Clarifications:

1. The drawings do not clarify what type of paint on the bridge. Do you want 2-coat vs. 3-coat urethane vs. 3-coat organic zinc? Which one do you want us to submit for the bid as the specifications do not say?

Response: Three (3) coats of paint per spec 975-2.3.1 and Table 975-1.

2. The plans call for the bridge to be fabricated from steel. Will you accept/approve an alternative option for aluminum?

Response: Yes, aluminum will be considered.

3. Please clarify the intent of how the bridge is to be received per this bid. Is it the intent for the bridge to be delivered when a contractor, hired under separate contract, is ready to set it? Or, is it the intent of this bid for the bridge to be delivered and staged without the site being ready for the install?

Response: The intent of this bid is for bridge to be delivered when a contractor is hired under separate bid and set when the site is ready.

4. Please clarify as there are two possibly conflicting statements in the Bid Package on page 10:

"IN THE EVENT THAT PERMITS ARE DELAYED OR THE VILLAGE'S CONTRACTOR IS NOT READY TO TAKE DELIVERY OF THE BRIDGE STRUCTURE IT MAY BE NECESSARY FOR THE BIDDER TO STORE THE BRIDGE UNTIL THE VILLAGE'S CONTRACTOR IS READY FOR DELIVERY."

And

"GRAND TOTAL COST SHALL INCLUDE DELIVERY OF THE STRUCTURE, F.O.B. ESTERO, FL WITH REMOVAL OF THE STRUCTURE FROM THE TRANSPORTER AND PLACEMENT AS DIRECTED BY VILLAGE STAFF."

Response: Store the bridge until the contractor is ready. The grand total includes delivery, transportation, and storage.

5. I wanted to inquire and confirm the finish of the bridge on this project to be weathering steel, galvanized, painted or galvanized and painted.

Response: See response to question 1.

6. Can you confirm the decking to be composite decking with no vehicle loading?

Response: Yes, the deck is composite with no vehicle loading.

7. Page 10 reads ".....removal of the structure from the transporter and placement as directed by village staff". I just want to confirm that is the village, not the supplier, that will be responsible for the equipment costs and coordination related to the offload and placement.

Response: No, that is not correct. The first part of the sentence quoted reads "GRAND TOTAL COST SHALL INCLUDE DELIVERY OF THE STRUCTURE F.O.B. ESTERO, FL WITH REMOVAL OF THE STRUCTURE FROM THE TRANSPORTER..." The supplier will be responsible for the equipment costs and coordination related to the offload and placement.

8. Page 12 mentions a finish color. Would a weathering steel bridge be considered in lieu of painted steel? Is there any specification for the paint system?

Response: No, the bridge will not be weathering steel, a color will be specified after selection. See response to question 1.
