<u>Question-</u> The packet for 2024-02 includes a "Performance and Payment Bond Public Construction Bond". Are you requesting that contractors submit a bond as part of this proposal?

Answer- No, this statement is intended to put submitting firms on notice that the selected firm will be required to obtain performance and payments bonds.

<u>Question-</u> Can we provide projects as references that are slightly older than the stated seven years?

Answer-Yes, please include dates for any project older than 7-years.

<u>Question-</u> Can work in communities that include sidewalks, pathways, parking lots, landscape, irrigation, and utilities be used in the evaluation criteria?

Answer-Yes, any work the responding firm feels demonstrates their ability to complete this project can be included.

<u>Question-</u> The solicitation indicates that "one reference must be for a residential jurisdiction with at least 4,000 residents". Do you mean residential community or a municipality?

Answer- The statement should read "one reference must be from a municipal jurisdiction with at least 4,000 residents".

<u>Question-</u>Please clarify the scoring calculation method. Page 4 states "the firm with the lowest score will be ranked first", but the 4 criteria percentage totals would indicate the proposer closes to 100% would be ranked first.

Answer- The selection committee will rank each firm based on the four criteria. Points will not be assigned for each criterion. Each firm will be ranked 1, 2, 3 etc. compared to the other firms. Each criterial rank will then be multiplied by the weight in parentheses. The weighted rank will be totaled for the composite rank. Following is a hypothetical example.

The average ranking of all firms from each selection committee member will be used to determine the firm rankings.

<u>Question-</u> What is the expected construction start for Phase 1?

Answer- Final construction schedule will be coordinated with the selected firm, but it is expected in summer 2024.
