Recommended Action: Motion to adopt Resolution No. 2018-18, thereby approving the Purchase and Sale Agreement with The Trust for Public Land.

Financial Impact: This real estate acquisition will require the Village to obtain financing and Staff is currently in the process of developing a Request for Proposals which will be issued to be consistent with the timing of the closing within 120 days from execution of the purchase and sale agreement. \$26,000,000

has been budgeted in 2018-2019, to include the \$24,562,500 purchase price and an additional \$1,437,500 in closing, debt issuance and design/development alternatives costs. These budgeted figures are listed as "Land Purchase A" in the approved Capital Improvement Projects. The purchase is funded on a long term basis without impact to our existing reserves or operating programs.
