I would like to recognize the Director of Public Works, David Willems, for the terrific job he did coordinating the development of the Bike/ Ped Master Plan and the comprehensive Capital Improvement Plan. Certainly the price tag for all the Biking and Pedestrian infrastructure is a sobering amount. However, when integrated into the long term CIP, as future Village Councils deliberate the approval of capital projects, they can weigh their decisions based on the priority the community has placed on multi-modal transportation and the feasibility within the economic realities at that time.

I would also like to recognize Councilman Nick Batos for his leadership in keeping alive the extension of the Florida Sun Trail

through Estero and Bonita Springs along the Seminole Railroad line. The Florida Sun Trail, when completed through Estero, will form a primary route for cyclists and pedestrians linking retail and food services at the intersection of Estero Pkwy & US 41 to the new River Park, the Estero community Park, the Hertz Hdq, Coconut Point and Lee Health Center. With the soon to be completed Estero Pkwy project, the north-south Sun Trail will link up with a safe route east to Ben Hill Griffin Pkwy and access to FGCU, Hertz Arena and Miromar Shopping Center. The Sun Trail will be a major infrastructure improvement which will further the Village of Estero's Vision.
