I'm happy to see that \$372000 is being spent for some of the storm water improvement projects. Thank you. I believe that the storm water improvements should be a very high priority. The River is one of our most precious assets and it is struggling with excessive sediment, debris, and fecal bacteria. A friend went down the River last week and he needed to power wash his boat to get the crud off of it - not the normal wash. It's not in good shape and it will only get worse unless the improvements are completed. I think of the sad Native American in an old environmental ad with a tear running down his cheek.

I ask that you bring in most if not all of the \$1,011,050 2021-2022 storm water budget into this physical year to get a jump start on cleaning up and unclogging the River, and let it flow.

Where's the money come from? Can we get money from the State and Federal grants? I know bike paths and other recreational areas are important - I support them, but can some of those be held off in favor of the River? Thank you for your service!
