Pelican Sound 2022-15 Pickleball					
Comments					

The ordinance contains the following paragraph:

The Pickleball Courts within the Golf Maintenance and Storage Area shall have an eight-foot tall fence and gates installed with 1/8 inch thick sound deadening black Acoustifence material to ensure that the sound generated by the pickleball facility does not exceed the maximum of 66 dBA. The black Acoustifence material will be made to meet the dimensional standards of the eight-foot fence associated with the pickleball courts. Each sound deadening curtain must be made of Industrial, UV resistant Acoustifence material.

But it does NOT state at what distance the sound is to be measured; nor from what location as referenced by the 4 sides of the court.

Also, the following is very imprecise:

If excessive noise complaints are received regarding noise from pickleball play, the applicant shall have 30 days to submit a noise mitigation plan to the Village staff for review.

What is excessive? An ordinal number? A percentage of doors? A percentage of people? And who decides?

Leaving the criteria so vague and arbitrary is not only useless, it is asking for confusion, clarification and controversy. We pay the attorneys enough money already.

Pelican Sound - Pickle Ball					
Comments					

The existing noise parameter (65 dB) is not appropriate for evaluating pickle ball. The pickle ball sound of paddle/ball/ground is a repetitive and irritating sound at far fewer decibels.

Every competent sound engineer would tell you that the human ear, especially as we get older, is extremely sensitive to sounds in the frequency range generated by pickle ball (2-4 kHz). Think of the "Crack" of a home run that can be heard well above the noise generated by thousands of fans. Imagine that noise repeated 15, 20 or even 30 times a minute.

And it's not just the homes. Most developments have a close by pool, a cabana, an adjacent tennis court, maybe bocce, or even an outside patio/dining area. All of these will suffer from the noise generated by pickle ball.

Even at say 50-55 dB and even 200-300 feet away, the sound is irritating.

I request that before you vote to approve ANY pickle ball that you visit a playing court and listen, simply listen. Take a sound meter with you if you want. Measure the sound close to the court. Then say 20 feet away; then 50 feet. You will still hear - loud and clear - the infamous Plunk, clack, whack, plink.

If you have never even heard it, I honestly don't know how you could in good conscience, possibly vote to permit it.
