In the initial Broadus Towers presentation in 2023, the Bella Terra Community was able to view a current AWS Band Coverage Map & a proposed AWS Band Coverage Map with the 148ft Monopole Cell Tower. The green area represented the reliable service area & the red area represented the unreliable service area. These two maps made it so easy for the Bella Terra Community to visualize the increase in the green reliable service area with the installation of a 148ft Monopole Cell Tower. The Bella Terra Community could easily see that there was still a significant area that was going to experience some unreliable service, however some increase at least was an improvement.

Dear Board Members,

I am writing to you today to be heard during your meeting over the proposed cell tower application at the community of Bella Terra. I am not an attorney nor do I practice law. My wife and I primary residence is 195 Violet Avenue Floral Park, NY 11001. We have been owners of a condominium in Bella Terra since 2014 that we frequent five to six times a year. It is my hope to petition a grievance and make submissions to oppose the application of a proposed cell tower in front of Bella Terra on 12 Acres of land our community of 1,899 residences collectively purchased in 2018. The location of the proposed cell tower is at Corkscrew Road and Bella Terra Blvd. The proposed height is 148 – 150 feet depending on who you speak to.

In March 2021 our community after one and a half years preparing to develop the 12 acres land into increased community amenities was voted down. Within thirty days following the amenities vote a new proposal was floated on Facebook about a cell tower. It is my opinion the Planning Zoning and Design Board has been provided a misleading survey conducted by Alliant to a select amount of families. The survey monkey survey unfortunately can be altered internally by the host. I personally have reached out to Alliant and they will not provide the survey along with all material sent at the time of the survey on or about July 21, 2021. What I was able to find is an email sent by alliantproperty.com stating Cell Phone Tower Survey, the email begins, by request of a handful of residents; the Master Board and the Technology Committee have been researching the feasibility of adding a cell phone tower to the 12 acres lot owned by the community. The survey I assume had a couple options proposed along with the ability to offer feedback. I question the results of the July 21, 2021 Survey Monkey due to a proposal on February 13, 2022 that following several Town Hall meetings about improving the amenities here in Bella Terra with a questionnaire to answer. The main question was 3) What would your household like to see happen to the 12 acres that Bella Terra currently owns in front of the community? Answers: Either A) Develop the property for future use based on community input/approval____, or B) Do 521 chose to develop. Therefore 37% voted not to develop, yet, the Survey Monkey about a cell tower received nearly 81% Yes and 19% No. It is unknown what the yes or no response was towards, I have been unable to obtain the actual survey. On this alone would fail to approve a cell tower application because the numbers have been manipulated as to how many of the 1,899 residency actually are in favor of the cell tower. Yet it's this unacceptable Survey Monkey results that have been provided you,


the Estero Planning Zoning and Design Board misleading you to think a majority of the 1,899 residences are in favor of a cell tower. To be factual about the Survey Monkey many responding to the survey asked serious questions such as 1. I am having a difficult time responding to the survey. I feel a cell tower is a good idea but I feel it depends on where they want to locate it on the property. We need to keep in mind that at some point we may want to develop the land so placement is important. Next is the reply, I assume from Alliant: We understand, placement is paramount. At this time, we have some preferred areas, but are subject to Village of Estero placement requirements. If the placement of the tower is in a location that the Master Board feels doesn't not meet all the future needs of the community, we may choose not to pursue the tower. I have enclosed with this letter the two surveys' I have mentioned in this letter for your review.

This proposed cell tower in which you have from Broadus photos of the Tower as it would stand on the 12 acres of land at Bella Terra. Look again at those photos if you will. They are completely out of character of our community. Not to say that our Bylaws prohibit the use of antennas. The tower is within a few hundred feet of the children's bus stop on Bella Terra Blvd as well as a few hundred feet to our clubhouse/offices/gym/pool/soccer field/basketball court ect. Not to mention the tower is nearly 150 feet tall and the surrounding circumference of 150 in all directions must be cleared in case of a hurricane knocking it down or the tower catching on fire, which is a real possibility. Therefore what is left to reasonably develop on the land, certainly not amenities, certainly not a restaurant? Who wants to look out their window while eating and seeing a 150 foot cell tower? You therefore limit dramatically the future development of the 12 acres. Not to mention, the lease term is for 50 Years. We are talking 50 years Broadus has rights to retain our land at a pittance amount for \$2,500.00 a month and based on the meetings conducted by the Texas outfit they will not guarantee all the families of Bella Terra will have improved service. Plus the fact only Verizon has signed for service. Broadus sold the Board they would have a monthly income for Bella Terra of \$6,500.00 monthly. The \$6,500.00 is one-fifth the value Bella Terra should have negotiated. The cell tower will occupy 5,625 sq/ft of land to fence in the tower, then you need a 150 foot call circumference adding amount another 5,000 sq/ft give or take totaling 10,000 sq/ft of land owned by the residence of Bella Terra for 50 years at \$2,500.00 a month. Meaning, we are leasing for 50 years land at \$.25 cents a square foot while office rent on average in Lee County is \$21.00 a square foot. Once you reduce cost of the \$2,500.00 monthly maybe the 1,899 families will have a reduction of \$1.00 a month towards their HOA Fees. Yet, a 3,000 sq/ft home in Bella Terra is renting for \$8,500.00 a month. Do the math, this is unreasonable and a no vote to the proposed tower should be issued, hopefully you agree.

That area has been considered, but would require a very long access road. Again, placement will be up to the Village of Estero.

I would like more information. Which cell companies would own the tower? Do they need a road for access to the tower that will impact our future use of the property?

We really need more information.

Three carriers are being proposed – Verizon, AT&T, and T-Mobile. Yes, an access road will be required, and is being considered in the overall placement. At this time, this is all the information we have. The Master Board did not want to move forward with a contract or permitting until the general sentiment of the community was gathered.

Umm! I need more info before the survey can be answered. 1) who is paying for the tower installation and what is that cost? 2) who pays for tower maintenance and repairs? If the HOA, then what are the estimated annual costs? 3) are there insurance costs for damage and/or liability with this tower? If so, what's the estimated annual cost? 4) are there carriers already interested in leasing or is this being installed on speculation? 5) is the \$6500 monthly revenue gross or net?

Great questions! 1. The tower company, we do not know their cost, but it is ZERO cost to Bella Terra. 2. The tower company. No operating costs for Bella Terra. 3. The insurance will be the tower companies' responsibility. ZERO cost to Bella Terra 4. Yes, Verizon, AT&T and T-Mobile are all on board. 5. Gross.

Would have been more appropriate if you disclosed the exact location. As a prior board member and President of the Single Family Homes, this was discussed prior but the placement was an issue. If this is our front on the open acreage we own, that differs than if implanted at the back of the property are previously discussed. I would be in favor of one but not the other.

The exact location cannot be determined until the permitting process starts with the Village of Estero. The only location being considered by the Master Board is placement on the front 12 acres, nothing deeper into the community is being considered.



The Cell Tower is a 50 Year Lease.

Additional time is necessary over the location of the tower that reaches now nearly 180 Feet. Only 40% of the Bella Terra residence have participated in the proposal. Sixty percent have remained without being counted in any survey either pro or opposed. When Bella Board states 80% approve is misleading. It's 80% of respondents not 100% of Bella residents. A greater number are coming out with disapproval of the location of the tower at the entrance of Bella Terra.

I'd like to share what I hope will impact the board's decision on Wednesday: Written and posted on Bella Terra Amenities Facebook

The Cell Tower is a 50 Year Lease, what's another 6 months? Verizon and T-Mobile have stated last month there were issues all along since Ian occurred that hadn't till recently been resolved. Verizon and T-Mobile also stated last month their current towers will have 5G Advanced Technology. I've never been in favor of this project, all it does in the long run is embattle better use of the 12 Acres for the next 50 potential years. The Tower took precedent during the time the new amenities were being proposed and as soon as the amenities battle ended the push for the Tower began. First it was a guarantee for 100% of Bella residence to have full service cellular usage, then it was we make money monthly, now the fight is we won't be able to call 911. Has anyone called 911 and not received service during an emergency? The Federal Communication Commission have 911 calls a priority over any other call at the time it's being made. I've found no record in Lee County reporting on missed 911 calls, but it's a huge talking point. All this over a 178-foot-tall Cell Tower that will not reach every home in Bella with perfect service, dropped calls will still occur. I'll state here that it's my belief a day will come in hindsight the decision to bring this Tower at the entrance of Bella Terra was not the best decision. I hope I'm proven wrong for the sack of those who really are passionate about the need for the Tower and improved service. We are all members of the same community, some of us speak up and express our displeasure many have shown their support and then there are probably 60% of the residence who choose to remain private. All that is being asked is consideration to move the tower to the west end of the property. I would be in favor of the tower being moved as opposed to its current location. The decision is not as many stated, the Village of Estero decision it it's ours, along with their approval. Broadus would have paid for the road if that was our choice. There is a meeting on May 01 and ecomments are allowed to be written for those in favor and those who are not in favor. But in the end, we are all a community and my wife and I love this community and will spend time her for the rest of our lives and hope our children and their children find the same love for Bella Terra as we have.

One more point on location is a County of Estero access road available between Bella Terra and Corkscrew Shores that may be considered to place the tower in the rear of Bella Terra that is having the poorest service. This is county land that potentially may be better suited. There is also at the front entrance a Hotwire Communications Building that currently exists that the tower will be placed next to. What are the possibilities of the tower falling within the 180 foot radius? We can't just hope that for 50 Years it will withstand all conditions that may occur.

I'd like to make one additional remark. As far as improved service, I currently have Verizon and the dropped call area entering the condo's off Corkscrew Road where I previously had interrupted service no longer exists. We were at our condo in February and March without any disruption of service as we had previously.

Please allow additional time over the location of the tower. What is decided represents 50 Years. Bella Terra need participation of 100% of its residence not 40% as they currently have surveyed.

As this has been quite a journey, I would like to add my support for the tower. We have little to no service in the community and the handful of dissenters do not represent the 80+% supporting the construction. Where have these persons been for the two years this has been worked on. The board has been nothing but transparent, has held town halls, has published the details and updates in agendas, newsletters, and blasts to the community, and all documents published on the community portal for ANYONE to see and question. The claims of adverse health concerns are ridiculous as even the American Cancer Society which has been studying this for 20 + years has found no correlation and says that "non-ionizing radiation (similar to a microwave oven) are not cancer causing and the FCC, NTP, WHO have classified RF wavbes from a cell phone tower as cancer causing.
