I Linda Veraja am a homeowner residing at 21510 Oaks of Estero Circle, Estero, FL 33928. Our HOA owns and has maintained the easement titled the Palms of Estero LLC which is the most northwestern portion of Block Lane, making me an "interested party" in regards to the Village of Estero Council Meeting Nov. 6, 2025, Agenda item 6. H. In fact my property is immediately adjacent to this corner of Block Lane and next to the Estero Community Park. I am strongly opposed to the Village of Estero authorizing any taxpayer funds to look into the proposed acquisition since I am confident that our HOA will not support relinquishing our property easement right of way on Block Lane and therefore would be a waste of taxpayer dollars. Neither our HOA nor residents were directly notified about this proposal, which was discovered by a resident this weekend looking at the upcoming Council meeting agenda items. After an informal gathering of community members we wrote up a statement of opposition signed by more than half of the neighborhood, which can be presented at the meeting. I, and many others chose this neighborhood secondary to its unique character-being quiet and secluded, without much vehicular traffic. I would strongly oppose any future plans that would increase vehicular traffic and noise along Block Lane or allow vehicular access into the Estero
