- 8. COUNCIL COMMUNICATIONS / FUTURE AGENDA ITEMS:

Councilmember Ribble: Spoke regarding the FGCU foundation endowment.

Councilmember Errington: Spoke regarding the March 21, 2017 Planning and Zoning Board meeting regarding the comprehensive plan. She noted that the Estero Historic Preservation Citizens Committee has been looking at the historic area, which she believed was critical to designate.

Councilmember Boesch: Addressed concern regarding Senator Passidomo's bill related to Home Rule that was moving forward. Discussion followed related to the numerous emails Council has received; concerns being heard through the Florida League of Cities contacts; and the Village Attorney's upcoming meeting with key legislators to discuss impacts.

# 9. VILLAGE ATTORNEY'S REPORT:

Village Attorney Saunders reported on the legislative session in Tallahassee. He also indicated that he would be providing a report to Council next week.

## 10. VILLAGE MANAGER'S REPORT:

(a) 2016 Staff Projects Annual Report

Village Manager Sarkozy provided a brief overview of the report that included major accomplishments and highlights from 2016 as well as a preview for 2017. He indicated that the report will also be available on the Village website.

### 11. WORKSHOP ITEMS:

(a) Estero River Maintenance – Roland Ottolini, Director, Lee County Natural Resources Division

Roland Ottolini offered a PowerPoint Presentation and spoke to Lee County objectives for creek maintenance; 2016 and 2017 scope of work; and 2017 proposal and scope of work.

**Questions or Comments:** Councilmembers Errington and Boesch. Discussion included a description of the north and south branch; river clean up performed by the Estero River Boating Committee at the railroad bridge; and possible maintenance further upstream.

(b) Estero Parkway – Danny Nelson, Tetra Tech

Village Manager Sarkozy provided a brief introduction and explained that Tetra Tech was chosen from the pool of engineers that Council previously approved.

Danny Nelson offered a PowerPoint Presentation and spoke to information regarding the firm and team; Estero Parkway capital component of interlocal agreement background information; Estero Parkway existing conditions and needed improvements; phased approach – Phase 1 - road and sidewalk/linear park and Phase 2 - beautification; conceptual design; evaluation phase; design and implementation – Package 1 - roadway and sidewalk improvement and Package 2 - roadway beautification; and considerations by Council, including standards for landscaping, lighting and road signs; workshops and stakeholder meetings; and adoption of standards and guidelines.

**Questions or Comment:** Councilmembers Ribble, Boesch, Wilson, Errington, Vice Mayor Levitan, and Mayor Batos. Discussion included widespread communication regarding the project; project funding; landscaping; the project being unique and an example for future projects; and lighting.

**Questions or Comments:** Vice Mayor Levitan and Councilmembers Boesch and Errington. Discussion included the firm that the Village selected for the project; narrowing roads; and Estero Parkway improvement will be a long range plan.

The meeting went into recess at 11:31 a.m. and reconvened at 11:42 a.m.

## (c) Fee Reductions as an Incentive in Village Center

Village Manager Sarkozy provided a brief introduction. Community Development Director Gibbs reviewed the Village Center land use category as it relates to incentives and spoke to the idea of partnering with developers of projects on a case by case basis to incentivize the types of development the Village desires; one type of suggested incentive has been a partial reduction of building permit fees. Ms. Gibbs noted that permit fees, listed in the fee schedule adopted by resolution, did not provide for any reduction or waivers; if a reduction was desired, Council would need to amend the fee schedule.

Community Development Director Gibbs continued that a proposal from Mr. Wallace, Genova Partners, LLC, was requesting a waiver of fees for the parking that would be underground and a fee reduction for hiring a private provider company to conduct certain building inspections and plan reviews. Ms. Gibbs added that Florida statutes do not address this and local jurisdictions do not allow for fee reductions.

Questions or Comments: Councilmembers Boesch, Wilson, Errington, Vice Mayor Levitan and Mayor Batos. Discussion included setting precedent; incentives; benefit of underground parking; subsidizing or raising fees; possibility of a grant fund out of the general fund; developers' choice to hire a private provider to perform inspections; guest parking; staffing needs for building inspections; whether Lee Health would be requesting a fee waiver; length of time

for building completion; no other municipality or the county was allowing a waiver or fee reduction; and impact fees.

## (d) Developments in the DR/GR Area

Village Manager Sarkozy explained that this workshop item was intended as a general discussion. Community Development Director Gibbs reviewed the history of the DR/GR (Density Reduction/Groundwater Resource), a description of where it lies, and provided a summary of the projects (as provided in the staff report).

Questions or Comments: Vice Mayor Levitan, Councilmembers Boesch, Wilson, Errington, Ribble, and Mayor Batos. Discussion included water flow to Estero; negotiating an interlocal agreement with the county; increased vehicle trips; local schools at capacity; affecting the quality of life for Estero residents; and clear consensus of the Council that this is of great concern and something needs to be done.

Community Development Director noted that the Scope of Services for County Traffic Study was included in the staff report which includes an analysis of Corkscrew Road and developing a proportionate share for some of the developments, and environmental enhancement including restoration of flowway.

Brief discussion followed on how to proceed. Village Manager Sarkozy spoke to the stormwater study that would provide useful data to understand stormwater flow, groundwater infiltration, as well as saltwater intrusion. He also spoke to other issues that the county would need to address. He indicated that staff would provide further detailed analysis.
