#### 9. COUNCIL COMMUNICATIONS / FUTURE AGENDA ITEMS:

Vice Mayor Ribble: (1) Reported that he recently attended the Florida League of Cities annual conference in Hollywood, Florida and noted it was the 50<sup>th</sup> anniversary of

constitutional Home Rule in Florida. He shared information regarding workshops held at the conference.

Councilmember McLain: (1) Reported that he recently attended a meeting with the Koreshan State Park new Park Ranger, Park Manager, and the new President of the Friends of Koreshan State Park Board of Directors. He also spoke regarding Friends of Koreshan State Park brochures.

Councilmember Errington: (1) Requested that a workshop be scheduled before the end of December with Bonita Springs Utilities and Lee County Utilities in order for them to present their recent water quality reports. (2) Addressed red tide and blue green algae creeping into various parts of the Village and large bodies of standing water. (3) Inquired regarding the Village being proactive concerning dirt from excavation of an agriculture field.

Councilmember Batos: (1) Reported on his work with the Estero Education Initiative as a result of his liaison role with Lee County School District. He also spoke regarding a volunteer system that was in place and a local business program.

Councilmember Wilson: (1) Conveyed appreciation to Lee County for approval of their 2018-2019 budget which included funding for the design phase on the widening of Corkscrew Road as well as other temporary improvements.

Mayor Boesch: (1) Reported that the six municipalities in Lee County have reignited a coalition to discuss the red tide and blue green algae issue; a meeting will be scheduled at some point in the future.

- 12. WORKSHOP ITEMS:
- (a) Property Assessed Clean Energy (PACE) Program

Village Finance Director Roberson provided an introductory explanation and spoke to preliminary inquiries of the tax collector and the people who will run the PACE program.

Davesh Nirmul, Regional Director, Government Relations, Ygrene Energy Fund, offered a PowerPoint Presentation that provided the background of PACE; its benefits to property owners, local municipalities, and lenders; the types of properties and improvements; qualifications for property owners; and PACE assessments.

Ron Hanson, Simon Property Group, addressed Council comments and stated that PACE was designed to allow property owners to upgrade to new systems. He noted that the Village could put it in place for commercial properties only.

Questions or Comments: Councilmembers Levitan, McLain, and Vice Mayor Ribble. Discussion included how much of the program in Florida was providing funds to developers for commercial properties as opposed to homeowners; concern that properties may meet the criteria, however, cash flow of the individual may not; and an inquiry whether the PACE program provided assistance with failing septic systems.

## **(b)** Proposed Land Purchase

Village Manager Sarkozy explained that the workshop was regarding a proposed land purchase of a 62.2-acre site known as "Estero on the River" located at the corner of Corkscrew Road and US 41. He provided information received from public outreach regarding land preservation; feasibility; accessing community waterways; conducting a community needs and assessment study; Village Center master plan and survey; bike and pedestrian improvements; and parks and open space. Village Manager Sarkozy stated that this property had been in the Village's interest and explained that Council was not arbitrarily and independently looking to purchase this property, but was doing so based on comments and feedback received from residents. He further explained that, from the beginning, Village Council decided not to move forward with property purchases unless there was strong community input.

Mr. Sarkozy explained why the property known as "Estero on the River" was being brought forward to the Council for consideration and provided the property description and opportunities to connect this property with Koreshan State Park as well as a Rails-to-Trails opportunity. He explained what could be developed on this property zoned for commercial development if the Council decided to pass on this opportunity. Mr. Sarkozy provided information on the proposed purchase price and noted that a potential purchase by the Village would not affect current operations. He then provided information on potential projects and the vision of the various uses of the property.

Questions or Comments: Vice Mayor Ribble, Mayor Boesch, and Councilmembers Errington, Wilson, McLain, and Levitan. Discussion included real estate attorney services; utilizing Land Use Counsel Stroud to consider any potential zoning issues; Village needing more park and recreation space; protecting the Estero River; the need to have a highly qualified consultant to help design the property; this was an exciting investment for the Village and that this parcel met the benefit test of the residents; potential of repayment; the Village had been working on a Comprehensive Plan for a long time and if the Village looked at its Vision Statement, the purchase of this property was in that vision; the Village should not be in the development business, however, owning this property was the best way to get a Village Center; and public participation in the process as well as transparency.

Rob Moher, President, Conservancy of Southwest Florida, made the following points: this was a legacy project; future generations would benefit; important cultural resources would need to be identified; the property was environmentally sensitive as well. He added that the Conservancy was approached by the Happehatchee Center; they would be a committed player and work collaboratively with the Village.
