RESOLUTION NO. 15 - 24

A RESOLUTION APPOINTING INITIAL BOARD MEMBERS
TO THE VILLAGE OF ESTERO DESIGN AND REVIEW
BOARD; ESTABLISHING INITIAL TERMS OF THE
MEMBERS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Village of Estero is a newly incorporated municipality; and

WHEREAS, the Village Council adopted Ordinance 15-01, establishing and creating the
Village of Estero Design Review Board; and

WHEREAS, Ordinance 15-01 provides that:

...The Board shall be composed of eight members appointed by the Village council for
terms of two years, except for the initial terms of the Board upon its creation. The terms
shall be staggered such that not fewer than three nor more than four terms shall expire
each year.

NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,
Florida:
