28	WHEREAS, it is the Village Council's desire to amend the wording of the Charter			
29	regarding Charter Amendment to be more comparable with the process to amend the Florida			
30	Constitution; and

32	WHEREAS, the Village Council would like to amend Section 11(2)(c) of the Village			
33	Charter to state:

35	Adoption of amendment – If the proposed amendment or revision is approved by a vote			
36	of at least sixty percent of the electors voting on the measure, it shall be effective at the time			
37	fixed in the amendment or, if no time is fixed in the amendment, 30 days after the amendment			
38	is adopted by the voters.
