5	A RESOLUTION OF THE VILLAGE COUNCIL OF THE
6	VILLAGE OF ESTERO, FLORIDA DECLARING A
7	STATE OF LOCAL EMERGENCY AND PROVIDING
8	FOR EMERGENCY GOVERNMENTAL OPERATIONS
9	RELATED TO HURRICANE IRMA IF DEEMED
10	NECESSARY AND IN CONJUNCTION WITH LEE
11	COUNTY; AND PROVIDING AN EFFECTIVE DATE.
12	
13	WHEREAS, the Village of Estero places the highest premium on safety of life and
14	property in the Village during storm events; and
15	
16	WHEREAS, Hurricane Irma poses a serious potential threat to the residents and
17	property of the Village of Estero; and
18	
19	WHEREAS, Hurricane Irma has the potential for causing extensive damage to public
20	utilities, public buildings, public communication systems, public streets and roads, public
21	drainage systems, commercial and residential buildings and areas; and
22	
23	WHEREAS, the Governor of the State of Florida has promulgated Executive Order
24	No. 17-235, wherein he found that a State of Emergency exists within the state of Florida; and
25	
26	WHEREAS, Chapter 252, Florida Statutes, authorizes municipalities to declare a state
27	of local emergency and to waive procedures and formalities otherwise required of
28	municipalities to take whatever prudent action is necessary to ensure the health, safety, and
29	welfare of the Village in the event of a state of local emergency; and
30	
31	WHEREAS, the Village of Estero relies on the Village Council and staff for leadership
32	during storm events; and
33	
34	WHEREAS, there may be instances when it is difficult or impossible to obtain a
35	quorum of Council membership for the purpose of convening an emergency meeting during a
36	state of local emergency; and
37	
38	WHEREAS, the Village Council desires to designate and delegate to the Village
39	Manager the authority provided under Chapter 252 to respond to the emergency should a
40	quorum of the Village Council be physically unable to meet.
41	
42	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,
43	Florida that the Village of Estero hereby declares a State of Local Emergency.

45	Section 1. The Village Council of the Village of Estero, Florida, if deemed
46	necessary and in conjunction with Lee County, hereby declares a state of local emergency and
47	the Council desires the Village Manager to avail himself to all powers available to Village
48	government provided in Chapter 252, Florida Statutes.
49	
50	Section 2. The Village Manager is provided plenary authority on behalf of the
51	Village Council of the Village of Estero to take all actions necessary for protection of persons
52	and property authorized by law.
53	
54	Section 3. As provided in Chapter 252 all normal formalities related to
55	procurement, incurring of obligations, and expenditure of public funds usually followed or
56	required by law are hereby waived.
57	
58	Section 4. All actions taken by the Village Manager, or taken at the direction of
59	the Village Manager pursuant to this Resolution are hereby ratified.
60	
61	Section 5. This Resolution shall take effect immediately upon adoption.
