19	WHEREAS, the gross taxable value for operating purposes not exempt from taxation
20	within the Village of Estero, Lee County, Florida has been certified by the Lee County Property
21	Appraiser to the Village of Estero as \$6,819,224,265;

23	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,

26	Section 1. The fiscal year 2019-2020 final ad valorem operating millage rate is
27	hereby adopted at 0.7726 mills, which is greater than the rolled-back rate of 0.7630 mills by
28	1.26% and the levy of an annual tax for said year is made.
29	
30	Section 2. The proposed millage rate is established to provide funding for the fiscal
31	year 2019-2020 budget and the resulting increase in ad valorem tax revenues is necessary to
32	fund various roadway improvements, intersection improvements, bicycle and pedestrian
33	improvements, landscaping and beautification projects and other future projects.

35	Section 3. This resolution shall take effect immediately upon adoption.
