19	item A.2. of the Personnel Policies needs to be amended to allow for additional pay out to
20	Directors and the Executive Assistant of up to a total of eighty (80) hours of unused PTO for
21	the fiscal years 2019-2020 and 2020-2021 only.

23	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,

26	Section 1. Resolution No. 2020-17 amends Section 3-03 PTO item A.2. as follows:
