5	A RESOLUTION OF THE VILLAGE COUNCIL OF THE

7	ADOPTING THE FINAL LEVYING OF AD VALOREM
8	TAXES FOR THE VILLAGE OF ESTERO, LEE
9	COUNTY, FLORIDA, FOR FISCAL YEAR 2020-2021;
10	AND PROVIDING AN EFFECTIVE DATE.

12	WHEREAS, the Village of Estero, Lee County, Florida, on September 23, 2020,
13	adopted Fiscal Year Final Millage Rate following a public hearing as required by Florida
14	Statutes 200.065; and
15	
16	WHEREAS, the Village of Estero, Lee County, Florida, held a public hearing as
17	required by Florida Statutes 200.065; and
18	
19	WHEREAS, the gross taxable value for operating purposes not exempt from taxation
20	within the Village of Estero, Lee County, Florida has been certified by the Lee County Property
21	Appraiser to the Village of Estero as \$6,913,761,445;
22	
23	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,
24	Florida:
25	
26	Section 1. The fiscal year 2020-2021 tentative ad valorem operating millage rate
27	is hereby adopted at 0.7726 mills, which is greater than the rolled-back rate of 0.7681 mills by
28	0.59% and the levy of an annual tax for said year is made.
29	
30	Section 2. The proposed millage rate is established to provide funding for the fiscal
31	year 2020-2021 budget and the resulting increase in ad valorem tax revenues is necessary to
32	fund various roadway improvements, intersection improvements, bicycle and pedestrian
33	improvements, landscaping and beautification projects and other future projects.
34	
35	Section 3. This resolution shall take effect immediately upon adoption.
