15	WHEREAS, Village Council approved an Interlocal Agreement with Lee County on		
16	July 22, 2020. The agreement requires the Village of Estero to pay Lee County for the

33	Section 1. Approves funding transfer of \$792,350 from General Fund		
34	unencumbered appropriations 001-000-5810300 into the Capital Projects Fund 300-000-		
35	3810001. Project expenditures in account 300-710-5416303 will not be increased as this		
36	budget amendment is to approve the use of Village funds and related funding transfer.
