11 12 13 14 15 16 17	WHEREAS , Resolution No. 2022-09, adopted the first budget amendment to the 2021-2022 fiscal year budget for additional revenue of \$8,482,207 in American Rescue Plan Act Funds; transfer of \$17,219,171 from debt retirement reserve fund, general fund unassigned fund balance, and capital project reserves to retire the debt on the Estero on the River Property; and additional capital projects expenditures totaling \$10,448,600 and;
18 19	WHEREAS, the capital project expenditures included \$4,250,000 in funding for the purchase of the Gulf Coast Driving Range property and;
20 21 22	WHEREAS, the activities of the driving range will be recorded in its own fund and;
23 24 25	WHEREAS , as provided in the Village Charter Section 8(6)(d), the following transfer of unencumbered appropriations will be transferred within the 2021-2022 Budget.
23 26 27 28	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero, Florida:
28 29 30 31	Section 1. The Village Council approves the final amendment to the 2021-2022 budget as follows:
32 33 34	Transferring already appropriated funding of \$170,000 in the General Fund to provide adequate funding for Information Technology expenditures.
35 36 37	Reducing expenditures within the Debt Service Fund of \$930,000 to align with actual expenditures.
38 39 40	Reducing expenditures within the Capital Projects Fund of \$1,750,000 to align with actual expenditures.
41 42 43	Reducing expenditures and revenue within the Capital Projects Fund of \$4,250,000 for the purchase of the Gulf Coast Driving Range property.
44 45	Transferring already appropriated funding of \$4,400,000 from the General Fund to establish the Driving Range Fund.
