9	ESTERO; AND PROVIDING FOR AN EFFECTIVE

12	WHEREAS, the U.S. Bicycle Route System (USBRS) is developing a national
13	network of numbered bicycle routes to facilitate bicycle travel on appropriate roads, paths, and
14	highways over routes that are desirable for interstate bicyclists; and
15	
16	WHEREAS, the USBRS is officially approved by the Florida Department of
17	Transportation (FDOT) and the American Association of State Highway Transportation
18	Officials (AASHTO) and currently encompasses 14,000 miles in 31 states, and will be over
19	50,000 miles upon completion; and
20	
21	WHEREAS, in 2018, 14 miles from Georgia to Madison, Florida, was designated as
22	USBR 15; and
23	
24	WHEREAS, there is a proposal to extend USBR 15 in Florida by 496 miles from
25	Madison to Miami; and
26	
27	WHEREAS, the alignment of the USBR 15 in Southwest Florida will run through
28	Polk, Hardee, DeSoto, Charlotte, Lee, and Collier Counties, providing economic development
29	via bicycle tourism; and
30	The old of the teathorn, and
31	WHEREAS, the attached USBR15 alignment along Estero Parkway and Three Oaks
32	Parkway in Estero has received local input from the Lee County MPO Bicycle Pedestrian
33	Coordinating Committee (BPCC); and
34	Coordinating Committee (B1 CC), and
35	WHEREAS, the Adventure Cycling Association (ACA) is the technical support
36	organization to AASHTO for the USBRS and has worked with AASHTO for 16 years to
37	identify bicycle routes; and
38	identify dicycle foutes, and
39	WHEREAS, a representative from ACA stated that Village will incur no costs
40	associated with said national bicycle route through Village;
