13	WHEREAS, Resolution No. 2021-22, adopted the 2021-2022 fiscal year budget; and
14	WHEREAS, Resolution No. 2021-22, adopted the 2021-2022 listed year budget, and
15	WHEREAS, Village Council has approved various capital improvement projects
16	during the current fiscal year, previously not included in the original 2021-2022 fiscal budget;
17	and

19	WHEREAS, Village Council has received additional funding from the American
20	Rescue Plan Act (ARPA); and
21	
22	WHEREAS, Village Council has approved retiring the debt on the Estero on the River
23	Property; and
24	
25	WHEREAS, the Village Budget should be amended to amend the Fiscal Year 2021-
26	2021 revenue from \$15,181,963 to \$23,664,170 an increase to the original budget of
27 28	\$8,482,207, for recognition of American Rescue Plan Act Funds; and
29	WHEREAS, the Village Budget should be amended to amend the Fiscal Year, 2021-
30	2022 Debt Retirement Reserve, Capital Reserve appropriations, General Fund Unassigned
31	Fund Balance usage and the payoff of the 2019 \$20,0000,000 debt instrument; and
32	Taila Balailee asage and the payoff of the 2019 \$20,0000,000 dest histalinent, and
33	WHEREAS, the Village Budget should be amended to amend the Fiscal Year 2021-
34	2022 Capital Project Budget from \$19,206,200 to \$29,650,800 and increase the original budget
35	of \$10,448,600 to fund additional bicycle & pedestrian projects, utility extension projects,
36	parks & recreation projects, and land purchases; and
37	
38	WHEREAS, as provided in the Village Charter Section 8(6)(d), the following
39	Appropriations and Transfers of unencumbered appropriations will be added to the 2021-2022
40	Budget.

42	NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero,
43	Florida:

45	Section 1. The Village Council Approves the First Amendment to the 2021-2022
46	Budget as follows:
47	
48	Revenue: Increase from \$15,181,963 to \$23,664,170 to recognize \$8,482,207 of
49	additional funds from The American Rescue Plan Act.

51	Debt Retirement: \$17,219,171 transfer from debt retirement reserve fund, general fund
52	unassigned fund balance, and Capital Project Reserves to retire the debt on the Esterc
53	on the River Property.
54	
55	Capital Project Expenditures: Increase from \$19,206,200 to \$29,650,800 an increase of
56	\$10,448,600 to add new projects to the Fiscal Year 2021-2022 budget.
57	
58	Section 2. This Resolution shall take effect immediately upon adoption.
