RESOLUTION NO. 2022 -32

A RESOLUTION APPROVING A LANDSCAPE MAINTENANCE AND INSTALLATION AGREEMENT BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND THE VILLAGE OF ESTERO FOR MAINTENANCE OF LANDSCAPING FOR SPECIALIZED LANDSCAPING AND IRRIGATION WITHIN THE INTERCHANGE AT SR 93 (I-75) AND CORKSCREW ROAD; AUTHORIZING THE VILLAGE MANAGER AND VILLAGE AGENTS TO TAKE ALL ACTIONS NECESSARY TO EXECUTE AND IMPLEMENT THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Constitution and Charter of the Village of Estero, permit the Village to provide for the health, safety, and welfare of its citizenry: and

WHEREAS, State and Village objectives both include the provision of especially aesthetically pleasing vegetation along roadways within the Village; and

WHEREAS, the State is providing installation of landscaping and irrigation at the intersection of SR 93 (I-75) and Corkscrew Road within the Village and is seeking an agreement with the Village for the Village to take responsibility for maintenance of the specialized landscaping and irrigation at the intersection;

NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero, Florida:

Section 1. The Village Council for the Village of Estero, Lee County, Florida hereby approves A LANDSCAPE MAINTENANCE AND INSTALLATION AGREEMENT BETWEEN THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION AND THE VILLAGE OF ESTERO FOR MAINTENANCE OF LANDSCAPING FOR SPECIALIZED LANDSCAPING AND IRRIGATION WITHIN THE INTERCHANGE AT SR 93 (I-75) AND CORKSCREW ROAD, a copy of which accompanies this Resolution, and which will be kept on file with the Village.

Section 2. The Village Manager is hereby authorized to execute the Agreement and through staff and/or agents of the Village, is hereby authorized to take all actions necessary to implement its requirements.

Section 3. This Resolution shall take effect immediately upon adoption.


