

RESOLUTION NO. 2024-08

A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF ESTERO, FLORIDA, AUTHORIZING AND DIRECTING THE VILLAGE MANAGER TO PREPARE AND SUBMIT COMMUNITY DEVELOPMENT BLOCK GRANT-DISASTER RECOVERY PROJECTS TO THE LEE COUNTY HURRICANE IAN PUBLIC FACILITIES AND CRITICAL INFRASTRUCTURE PROGRAMS; AUTHORIZING THE VILLAGE MANAGER OR HIS DESIGNEE TO ACCEPT AND EXECUTE THE CDBG-DR GRANT AGREEMENTS WHEN RECEIVED FROM LEE COUNTY; AUTHORIZING THE VILLAGE MANAGER TO AMEND THE PROJECTS, AS NEEDED, WITH SUCH AMENDMENT(S) COMPLYING WITH THE RULES AND REGULATIONS OF THE LEE COUNTY HURRICANE IAN RECOVERY AND RESILIENCY PLANNING PROGRAM; MAKING RELATED FINDINGS; PROVIDING FOR SEVERABILITY AND FOR AN EFFECTIVE DATE.

WHEREAS, Community Development Block Grant Disaster Recovery (CDBG-DR) grant funds are appropriated by Congress and allocated by the United States Department of Housing and Urban Development (HUD) to rebuild disaster-impacted areas and to provide funds to most impacted and distressed areas for disaster relief, long-term recovery, restoration and infrastructure, housing and economic revitalization; and

WHEREAS, the United States Department of Housing and Urban Development has allocated one billion dollars in Community Development Block Grant-Disaster Recovery funding to Lee County to assist in recovery efforts from Hurricane Ian for the purpose of addressing unmet needs that other federal agencies have not yet addressed; and

WHEREAS, the Village Manager recommends that the Mayor and City Council authorize staff to take the grant-related actions set forth in this Resolution related to grants from the Lee County Hurricane Recovery and Resiliency Planning Program.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF ESTERO, FLORIDA, THAT:

1. The Village Council hereby authorizes and directs the Village Manager, Steve Sarkozy, and Finance Director, Kevin Greenville, to apply for CDBG-DR funding for the Village of Estero Utility Extension Project, Estero River Heights and Sherril and Luettich Utility Extension Project, Charing Cross and Estero Bay Village Utility Extension Project, and the Broadway Avenue West Improvements Project from the Lee County Hurricane Ian Public Facilities and Critical Infrastructure Programs.
2. The Village Council hereby authorizes and directs the Village Manager, Steve


Sarkozy, and Finance Director, Kevin Greenville, to accept and execute any and all grant agreements upon receipt from Lee County for the projects approved based on Village CDBG-DR applications to the Lee County.

3. The Village Council hereby authorizes the Village Manager, Steve Sarkozy, and Finance Director, Kevin Greenville, to amend the projects, with such amendment(s) to comply with the rules and regulations of the Lee County Hurricane Recovery And Resiliency Planning Program.

BE IT FURTHER RESOLVED that if any section, subsection, sentence, clause, provision or word of this Resolution is held unconstitutional or otherwise legally invalid, same shall be severable and the remainder of this Resolution shall not be affected by such invalidity, such that any remainder of the Resolution shall withstand any severed provision, as the Village Council would have adopted the Resolution even absent the invalid part.

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately upon adoption.
