RESOLUTION NO. 2016 - 30

**A RESOLUTION OF THE VILLAGE COUNCIL OF THE
VILLAGE OF ESTERO, FLORIDA, AUTHORIZING THE
WAIVING OF COMPETITIVE BIDDING PROCEDURES
AND AUTHORIZING THE VILLAGE MANAGER TO
EXECUTE A CONTRACT FOR PUBLIC WORKS
SERVICES WITH JGUCCIARDO CONSULTING LLC; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the Village requires public works services for the transportation network with the Village; and

WHEREAS, the attached contract negotiated with JGucciardo Consulting LLC was found to be sufficient for the Village's needs. John Gucciardo (principal of JGucciardo Consulting LLC) has extensive experience in municipal public works services. He previously held the position of Assistant City Manager for City of Bonita Springs and had management oversight for the public works department. The proposal establishes an hourly rate of \$100; based upon current time estimates, has an approximate cost of \$15,600 per year, and will be funded from the 2016-2017 fiscal year public works budget; and

WHEREAS, staff is recommending a waiver of the competitive bidding procedures as provided in Ordinance 2015-06, Section 5, and requests authorization of the Village Manager to execute a contract with JGucciardo Consulting LLC as provided in Ordinance 2015-06, Section 2(C).

NOW, THEREFORE, be it resolved by the Village Council of the Village of Estero, Florida:

Section 1. The competitive bid process is waived and the Village Manager is hereby authorized to execute a contract with JGucciardo Consulting LLC.

Section 2. The fiscal impact of the contract is approximately \$15,600 per year and the current year amount will be funded from the 2016-2017 fiscal year public works budget with a year-end budget amendment, if necessary, to fund the public works services function.


Section 3. This Resolution shall take effect immediately upon adoption.


